I/we agree to handle, pack, process, and move regulated articles in accordance with applicable plant quarantines; use all permits and certificates in accordance with instructions; maintain and offer for inspection such records as may be required; and abide by the following stipulations:

- Emergency Apple Snail Regulation (see attached).
- To ship only nursery stock (including aquatic plants) into Mississippi that is free from apple snail in any stage of development (Ampullariidae).
- Any nursery premises, production areas, or shipments found with apple snail in any stage of development, will be cause for this agreement to be cancelled and any certificates revoked.
- To permit authorized representatives of the FDACS to have access to records pertinent to this agreement
- All certificates issued under the authority of this agreement shall remain the property of the FDACS and shall be relinquished upon request.
- The intent of this agreement is to facilitate the shipment of regulated commodities into Mississippi without individual, signed certificates of inspection.
- This agreement does not preclude Mississippi agriculture inspection of shipments at destination
- Violation of any stipulation of this agreement is grounds for suspension and may result in prosecution as provided by sections 581.141 and 581.211, Florida Statutes.
