I / we agree to handle, pack, process, and move regulated articles in accordance with applicable plant quarantines; use all permits and certificates in accordance with instructions; maintain and offer for inspection such records as may be required; and abide by the following stipulations:

- To ship only nursery stock (including sod) into North Carolina that is free from Tropical Spiderwort (*Commelina benghalensis* L.).
- Any nursery production areas or shipments found with Tropical Spiderwort (*Commelina benghalensis* L) will be cause for this agreement to be cancelled and any certificates revoked.
- To permit authorized representatives of the FDACS to access and review records pertinent to this agreement.
- All certificates issued under the authority of this agreement shall remain the property of the FDACS and shall be relinquished upon request.
- The intent of this agreement is to facilitate the shipment of regulated articles into North Carolina without individual, signed certificates of inspection.
- This agreement does not preclude North Carolina agriculture inspection of shipments at destination.
- Violation of any stipulation of this agreement is grounds for suspension and may result in prosecution as provided by sections 581.141 and 581.211, Florida Statutes.
- This agreement will expire two years from the date of issue.
